The Chairperson, **Prof. Ch. Gopal Reddy**, welcomed all members to the first IQAC meeting in the third assessment cycle and appreciated the efforts that led to the University's NAAC grade improvement from B (2.32 CGPA) to B+ (2.65 CGPA).

Item No. 1: Review of NAAC Peer Team Report

The Director, IQAC, presented the strengths, weaknesses, opportunities, and challenges identified by the Peer Team during their visit from 24th to 26th May 2023. The members deliberated on the key areas that require improvement and agreed to take necessary measures.

Item No. 2: Action Plan to address the aspects pointed by the NAAC Peer Team

After thorough discussions, the committee proposed the following initiatives to overcome the aspects pointed out by the NAAC Peer Team:

1. Encourage faculty members to apply for research projects under national and international funding agencies.
2. Organize research workshops and training programs to build faculty capacity.
3. Encourage faculty and students to take up live industry projects.
4. Plan to conduct Awareness Program on Filing Patents.
5. Strengthen existing MoUs and initiate new collaborations with industries.
6. Seek funding from government schemes (UGC, DST, and AICTE) to improve laboratory facilities.
7. Strengthen the activities of MGU Development Fund – the Section 8 Company of the University to attract more CSR Funding.
8. Upgrade libraries with more e-resources and research databases.
9. Identify corporate partnerships for research and academic development.
10. Encourage faculty to develop university-specific online courses.
11. Introduce new Postgraduate, and Certificate Courses based on market demand.
12. Leverage the University's proximity to Hyderabad's Hi-Tech City to establish internship programs and research collaborations.
13. Strengthen the placement cell and create industry-aligned training modules.
14. Organize mock interviews, resume-building workshops, and job fairs.
15. Introduce soft skills training and personality development programs.
16. Encourage the students participation in debates, seminars, and public speaking forums.

The committee engaged in a discussion on significant institutional developments, with a focus on research and student training opportunities. The following recommendations were noted:

- A **Memorandum of Understanding** was signed with **Edunet Foundation** to facilitate training for teachers and students in cutting-edge technologies. The foundation has proposed the establishment of an **advanced Computer Laboratory** for this purpose. Plans were discussed to **effectively utilize this facility for employment-oriented skill development programs**.
- It was proposed to **organize an additional seminar on Intellectual Property Rights (IPR)** to enhance awareness among faculty and students regarding **patent policies and intellectual property management**.
- The committee reviewed the **planned initiatives under Business Chair Activities** and discussed strategies for their effective implementation.
- A **Mega Placement Drive** was proposed, in collaboration with the **Local Administration**, to provide large-scale employment opportunities for aspirants across the jurisdictional districts.
- The progress of activities at the **Telangana Academy for Skill and Knowledge (TASK) Centre** was reviewed, with suggestions to expand training programs to enhance student employability.
