THIS DEED made at Anneparthy Village, Nalgonda Mandal, Nalgonda District, Telangana 508 254 on this 14 day of September, Two Thousand Twenty between Mahatma Gandhi University, a State Government University established in the year 2007 vide Government Orders in G.O.19/HE (UE-II) Department, dt: 13/3/2007 by suitably amending the Andhra Pradesh Universities Act 1991 under Section-3(1) in L.A.Bill No.4 of 2007. This University has been renamed by the Government of Andhra Pradesh as Mahatma Gandhi University by amending the Schedule of Act 4 of 1991, which was published in the A.P. Gazette on April 28, 2008 of the ONE PART, represented by its authorised representative Prof. M. Yadagiri, Registrar (hereinafter referred to as the "Lessor" which expression shall include its successors and assigns);

AND

Dr. Vishnuvardhan Reddy Sultanpuram (hereinafter referred to as the "Lessee" which expression shall include its successors, incorporated companies/firms and permitted assigns) of the OTHER PART. Aged 42 years S/o Hanmanth Reddy Sultanpurarn, residing at Plot No. 102, Phase-1, Sri Sai Dwarakapuri Colony, Cherlapally, Nalgonda, Telangana - 508001, India.

WHEREAS:

- A. The Lessor Head Quarters were located in Nalgonda town during the reporting year 2010-11 and its permanent campus is being developed in 240 acres of land allotted to the Lessor on the state highway (Nalgonda Narketpally) at Anneparthy, 7kms from Nalgonda town.
- B. Pursuant to the allotment/alienation of the said land by the GoAP, the Lessor has developed the aforesaid land and established a self-contained infrastructure facility on the said land which contains developed space, buildings, laboratory spaces, with the objective to promote and run a educational institute with modern facilities to attract students and other entities or any other person to undertake Masters as well as Doctorate students in areas such as life sciences and chemical sciences etc. As part of policy from GoTS as well as GoI, the Lessor is also keen to develop academia industry partnership.
- C. The Lessee has for the purpose of setting up a Research & Development (R&D) Unit for carrying out research, design, development for product (but not any kind of commercial manufacturing activity), requested the Lessor give part of room F18 situated in the University College of Science & Informatics (UCS&I) in the first floor of Science Block at MGU, Anneparthy Campus, more particularly described in Schedule I hereto (hereinafter referred to as the demised premises).
- D. The Lessor has agreed to give on lease the demised premises to the Lessee for setting up its R&D Unit for the period and on the terms and conditions mentioned hereunder.

NOW THIS INDENTURE WITNESSETH AND IT IS HEREBY AGREED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS

Lease

In pursuance of the Lessee agreeing to take on lease the demised premises from the Lessor and in consideration of the rent hereby reserved and of the terms and conditions, covenants and agreements herein contained and on the part of the Lessee to be observed and performed, the Lessor doth hereby demises unto the Lessee, all the demised premises, particularly described in Schedule I hereto, TO HOLD THE SAME UNTO the Lessee for a period of 18 Months for the Part of F18 commencing from September 01, 2020 and ending on February 28, 2022 (hereinafter referred to as "the Fixed Period"),

YIELDING AND PAYING to the Lessor, during the Fixed Period, total rent as follows, without any deduction or set off other than statutory deduction:

- 2. The Lessee agrees, confirms and undertakes that the Lessee shall:
- 2.1 ensure that all the laws, statutes, ordinance, rule, regulation, requirement, licenses, permit, certificate, judgement, decree, order or direction of any government or quasi-governmental authority, agency, board, panel or court has been duly complied with and all requisite permissions and authorisations for carrying on its activities in the demised premises have been obtained and kept in force;
- 2.2 not hold the Lessor responsible or liable for any loss or damage suffered by the Lessee or its employees, servants, agents, its visitors on account of any theft, fire or other accident in or on the demised premises or any part thereof where such loss or damage is caused due to default or negligence of the Lessee or its employees, servant, agents or its visitors:
- 2.3 undertake necessary precaution while bringing and storing in the said demised premises any combustible or inflammable or hazardous materials or any dangerous things that may imperil the safety of the demised premises;
- 2.4 not use or permit the use of the demised premises for any other purpose than for which the demised premises is originally taken on lease and do or permit to be done any act which in any way will violate any law, statute, ordinance, code, rule, notification of any governmental or quasi-governmental authority or any other authority; not carry out any activity which is not in the nature of research and development;
- 2.5 not transfer, assign or otherwise dispose of or purport to transfer, assign or dispose of the Lessee's rights or obligations or interest hereunder by way of mortgage, charge, sub-lease, sale or other assignment, encumbrance, conducting arrangement, license or otherwise in any manner part with the possession of the demised premises or any part thereof or allow or purport to allow or create any lien, charge, attachment or other claim of whatsoever nature on the demised premises or any part thereof;

During the subsistence of this Agreement, the Lessee shall have right:

- 3.1 On all the results, output etc. of the work which was carried in the premises during this period; to carry out at its cost, interior work of the demised premises so as to suit the requirements of the Lessee by internal electrification for lighting, fans, power points, air-conditioning systems of all types, cabling for telecom, intercom and computer systems, fire fighting, non-permanent partitions and plumbing etc. However, that the Lessee shall not carry out any structural changes to the demised premises or changes in the external elevation of the building located on the demised premises;
- 3.2 upon expiry or termination of this Agreement, the Lessee shall be absolutely entitled to dismantle, remove and take away all the items of work, things, articles, equipment, consumables, chemicals, glassware, plasticware, labware, installations pursuant to the renovation work done by the Lessee on the demised premises etc. and hand over to the Lessor the demised premises in good condition excepting reasonable wear and tear.

All monies due and payable by the Lessee to the Lessor pursuant to this Agreement shall be paid by cheque or bank draft drawn in favour of the Lessor on a scheduled bank at Anneparthy, District Nalgonda and shall be so paid as to enable the Lessor to realise at par, the amount sought to be paid on or before the due date to which the payment relates.

- It is agreed by and between the parties that the courts/tribunals in Nalgonda shall have the exclusive jurisdiction in respect of any matter, claim or dispute arising out of or in any way, relating to this Agreement.
- This Agreement represents the entire Agreement of lease between the parties hereto on the subject matter hereof and shall be capable of variation only in writing by a note of amendment signed by and on behalf of the Lessor and the Lessee.
- Reference to Clauses and Schedules are to be construed as references to Clauses of and Schedules to this Agreement. Words imparting the plural shall, except where the context otherwise requires, include the singular and vice versa.
