$\frac{\text{RULES FOR TRANSFER OF STUDENTS INTO 2}^{\text{nd}} \& 3^{\text{rd}} \text{ YEAR DEGREE COURSES FROM}}{\text{OTHER UNIVERSITIES}}$

- 1. TRANSFERS ARE NOT PERMISSIBLE IN THE 1st YEAR OF THE DEGREE COURSE
- 2. Transfers into 2nd,3rdyear of B.A./B.Sc./B.Com courses from other universities will be considered, subject to the following conditions:
- a. The degree course which the candidate is pursuing at the parent University should have been recognized by the M.G. University
- b. At least two third (2/3rd) of syllabus of the 1st, 2ndyear subjects studied by the candidate at the parent University should be equivalent with the syllabus of the M.G. University.
- c. Candidates should have completely passed 1st/2ndyear examination at the parent University OR they should be eligible for promotion to 2nd, 3rd year degree course as per the rules and regulations of M.G. University viz. should have passed at least 50% of the subjects/papers.
- d. Candidates shall be admitted on transfer at M.G. University to the same course/combination which they have studied 1st/2ndyear of degree course at the parent University. Change of Group/Combination/Optional is not permissible.
- e. Candidates may be granted exemption from appearing and passing in such of those papers which are found equivalent and which they have passed at the parent University, securing 36% pass marks prescribed by the M.G. University. These papers will not be counted as backlog papers for purpose of promotion to next higher class.
- f. Candidates are required to appear and pass the papers of 1st, 2ndyear (both Theory and / or Practicals as the case may be) which they have not studied OR not passed OR secured less than 36% pass percentage prescribed at M.G. University OR which are not found equivalent at M.G. University, NO EXEMPTION WILL BE GRANTED IN SUCH PAPERS.
- g. Candidates are required to submit a certified copy of the detailed syllabus of the course pursued by them at the parent University in order to establish equivalence of the subjects for considering exemption.
- h. In case where the 1st/2ndyear examination passed by the candidate is a house examination conducted by the College and not by the University, no exemption would be granted and the candidates are required to appear and pass all the papers of 1st/2ndyear papers from M.G. University at the next immediate examination, without fail. In such case, these papers will not be treated as backlog papers for purpose of promotion.
- i. Once the candidates are granted admission on transfer into M.G. University they will be treated as students of this University. They have to appear and pass in (a) papers in which they failing or (b) where the syllabus is not equivalent, from M.G. University only and not from the parent University. Any examination appeared/passed from the parent University after the transfer will not be considered as valid.
- j. No Principal shall admit candidates directly on transfer without the prior approval of the University.
- k. In some cases, the candidates may be admitted on transfer provisionally, subject to production on Memo of Marks/Syllabus. In such cases, the candidates are required to submit the same within one month to the Registrar, MGU only and obtain confirmation orders.
- 1. In case where the candidates have not studied/appeared the compulsory subjects Part-I viz., General English, Second Language and Indian Heritage & Culture/Science and Civilization in I/II year at the parent University, they are required to appear and pass the same at the immediate next examinations from M.G.University.
- m. Applications for admissions on transfer shall not be considered unless they are accompanied with the following:
 - (i) Xerox copies of Memorandum of marks I, /II year degree course of the Parent University.
 - (ii) Challan Rs.1520/- (for the students seeking admission on transfer from Universities within the State) and Rs.3020/- (for the students seeking admission on transfer from Universities outside the State) drawn in favour of "The Registrar, Academic Audit Cell, Mahatma Gandhi University" (A/c. No. 624240 26709) (from Nationalized banks only)
 - (iii) Certified copies of the Syllabus of 1st/2ndyear Degree course studied at Parent University.
- n. Readmissions of students into II/III you in the same college of this University has to pay Rs. 500/- to the concerned Principal of the college. The Principal after admitting them have to send the list of the candidates along with a fee of Rs. 500/- per candidate in a consolidated challan drawn infavour of the "The Registrar, Academic Audit Cell, M.G. University" (A/c. No. 624240 26709) and submit the same on or before 27-09-2022 and seek necessary permission from the Director, Academic Audit, MGU.
