As part of the **Audit Diwas 2023** celebrations, the Comptroller and Auditor General (CAG) of India is organizing the second **National Online Essay Writing Competition** for the University students of the Country for spreading awareness among the youth about the institution of the CAG and generate appreciation of the role of the CAG in promoting public accountability & good governance.

Therefore, the students of your University are invited to harness their creativity and express ways in which the institution of the CAG can contribute to good governance.

The topic for the online essay competition for the year 2023 is '**Celebrating the resilience of the Indian Democracy and the role of the CAG of India**'.

**Eligibility for the participation** – Students under the age of 25 years as on 20 July 2023, enrolled in a course of study at an institution recognized by any University in India shall be eligible for participating in the competition. Employees of the IA&AD shall not be eligible for participating in the completion.

The essay may be in either English or Hindi and word limit is 1500 words and it is to be submitted by email at [essay2023@cag.gov.in](mailto:essay2023@cag.gov.in) on or before 1700 hrs of 20 August 2023. Only one entry from each participant will be considered.

**Awards-** The top three entries in each category (English and Hindi) will be awarded cash prizes of Rs.30,000, Rs.20,000 and Rs.15,000 for 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> rank winner respectively.
