These vacant seats may be filled up with the candidates who qualified in the PG Entrance Examination conducted by the Osmania University in the year 2018. If still some seats are unfilled, they may be filled up with the candidates who secured not less than 50% marks in the concerned qualifying examination in the order of merit.</i></p>
