Sir/Madam,

The University has been receiving several complaints from various students Organization stating that the Management of the Colleges/Institutions Under the Jurisdiction of Mahatma Gandhi University are running study centres of the other Universities and also conducting examinations of the Distance Education Programmes conducted by other Universities. The Secretary, Telangana State Council of Higher Education has also informed the University that they have been receiving several complaints in this regard and requested the University to take stringent action on the erring Management including disaffiliation of the college.

In view of the above, the following are the final instructions to the Managements of all affiliated colleges under Mahatma Gandhi University which are to be strictly followed.

- The Management are instructed that they should not run/conduct study centres/Examinations of other state Universities/Deemed to be Universities and private Universities and to close down study centres immediately, if already exists.
- 2. The colleges which are running study centres of others state Universities /Deemed to be Universities and private Universities in the affiliated colleges under the territorial jurisdiction form the competent authority of concerned University stating that the on-going study centre in the college is withdrawn.

3. The Managements are further warned that the University will conduct surprise inspections of the affiliated colleges which are running study centres and conducting examinations. If the affiliated colleges are still running study centres/conduct examinations of other state Universities /Deemed to be Universities and Private Universities and private Universities a penalty up to Rs:5.0 Lakhs will be imposed on such affiliated college and the affiliation of the college will be withdrawn permanently.
