The following resolutions are taken by the University, for implementation in this Spell of Examinations.

- 1. It is resolved that all the students shall be treated as deemed to be present for the duration of part of lockdown which is being the part of almanac.
- 2. It is resolved that, for the courses where first internal examination is completed and second is due and the student, who has written the first internal is exempted from undergoing second internal; and when the student has failed to attend the first internal shall be asked to submit an assignment.
- 3. It is also resolved that, for the courses where both the internal examinations are not conducted, in such all cases the students shall be asked to submit assignment with at least two essay questions from each unit.
- 4. It is also resolved to reduce the theory exam duration from 3 hours to 2 hours and proportionate decrease in the duration where it is less than 3 hours without effecting the existing credits/Max.Marks of the subject.

- 5. It is resolved to modify the question paper pattern with only essay questions double the number of units with open choice.
- 6. It is also resolved to conduct Practical Examinations with external examiners of nearest colleges only for this spell. The maximum duration is 2 hours to conduct practical examination with appropriate changes in number of questions.
- 7. It is resolved to conduct Project Viva / Seminar in virtual mode where ever they exist in curriculum.
- 8. It is also resolved to stop detention for this spell of examinations only, because of the specific prevailing pandemic situations and those who are paid examination fee only will be permitted to promote to the next semester by the University. However, the examination for the spell has to be undergo by the student as and when the situation will become normal/as decided by the University.
- 9. Further, It is resolved that to give directions and measures to be taken by examination centres for conduct of examination by duly following COVID-19 safety measures.
- 10. It is resolved that all the above decisions need to be taken for Under Graduate Programmes (BA, BSc, BCom, BBA), Post Graduate Programmes (M.A, M.Com, M.Sc, MSW), Integrated Courses (IPC and IMBA), Professional Courses (B.Tech, MBA, MCA, BEd, DPEd, BPEd and MPEd) and Oriental Courses for regular semesters and as well as for backlog semesters.
- 11. In addition to the above, it is also resolved that the duration and Question Paper Pattern for the left over papers of non conduct of year wise Backlog UG (BA, BSc, B.Com) programme are as usual,
