Sir/Madam,

I am pleased to inform you that in pursuance of the provisions of and on the recommendations of the Committee constituted, the Vice-Chancellor has accorded approval to invite the applications from the eligible Government/Government aided colleges where research facilities are available under the jurisdiction of Mahatma Gandhi University for recognizing as Research Centres and eligible teachers of the College as Research Supervisors to carry out research programmes leading to award of Ph.D. Degrees in various faculties by the University. Further, the University is going to issue notification for Ph.D. admissions shortly.

Hence, all the Principals of the eligible Govt./ Govt. Aided Colleges and permanent teachers are hereby informed to apply for recognition of their college as Research Centre and teachers as Research Supervisors as per the eligibility criterion prescribed.

The last date for applying is 15<sup>th</sup> March, 2022 by 5:00 p.m. and any application received after the due date will not be entertained.

## NORMS FOR RECOGNITION OF AFFILIATED COLLEGES (GOVERNMENT/ GOVERNMENT AIDED) AS RESEARCH CENTRES AND TEACHERS AS RESEARCH SUPERVISORS:

- Colleges having 5 years of existence within the territorial jurisdiction of Mahatma Gandhi university are eligible to be recognized as research centres for providing facilities in Ph.D. research, provided they have eligible Research Supervisors, required infrastructure and supporting administrative and research facilities.
- Colleges with adequate facilities for research as mentioned below are recognized as research centres to conduct research leading to the award of Ph.D. degree.
  - a. In case of Science & Technology disciplines, exclusive research laboratories with sophisticated state of the art equipment as demanded by the respective research areas and with provision for adequate space for research scholar along with computing facilities with dedicated internet bandwidth of 100 Mbps (yearly subscribed) should be available along with licensed software, and uninterrupted power and water supply. The approved laboratories must be updated with latest technology and adequate budget must be provided.
  - b. In case of Arts/ Humanities/ Social Sciences/ Commerce/ Business Management and other Non-laboratory subjects, the College should have sufficient space for accommodating the scholars allotted, at least one computer with internet connectivity of minimum 100 Mbps to each scholar, latest books and a minimum of 6 National level and 4 International Journals either in paper form or e-Journals. Department Reading room/ reference library is also required.
  - c. Earmarked digital library resources including latest books, Indian and International journals, e-journals, extended working hours for all disciplines, adequate space for research scholars in the department/ library for reading, writing and storing study and research materials.
  - d. The institutions seeking recognition as a recognized research centres of Mahatma Gandhi University shall apply in the prescribed application form

by paying a fee of Rs. 20,000/ (Rs. Twenty Thousand only) for each Subject/ Department to the Registrar, Mahatma Gandhi University.

- e. The College shall allocate adequate annual research grant (as applicable to the subject concerned) for conducting the research as shall prescribed by the Inspection Committee of the University which will inspect the Affiliated College after receiving the application.
- f. The affiliated Colleges should submit the reprints of at least six research publications in the concerned subjects emanated from the research activity carried out by its faculty in the last five years in reputed journals as proof of commitment of the college for research along with the application. The research publications so submitted shall be evaluated by a committee consisting of the Dean, Head and Chairperson, board of Studies of the concerned subject.
- g. The colleges should also provide with application the proof of its commitment for research activity by way of organizing at least two National Conferences/ Seminars/ Workshops (of not less than 2 days) in the last five years or its support and active participation in such programmes. Once the recognition is accorded by the University, the institutions should continue to participate regularly in such activities.
- h. At the time of application, the college should submit a written commitment duly signed by the Principal/ Correspondent to continue all the facilities for the research originally indicated. Any breach of this aspect, will be evaluated by inspection committee and the university reserves the right to revoke the recognition.
- The Colleges must have been functioning on regular basis with a clean record of academic discipline and environment offering the P.G. programme in the concerned subject/ discipline/ department in which it is seeking recognition for a minimum period of five years.
- 4. The college must have permanent/ continuous affiliation.
- The teacher must be a regular faculty member for recognition as Research Supervisor as per the university norms in each of the subject in which the recognition is sought.
- 6. The committee constituted by the University with following members will visit the college and submit the report to the University for the approval of the

Standing Committee of the Academic Senate and Executive Council of Mahatma Gandhi University.

- Dean, Faculty of the concerned subject
- Head, Department of the concerned subject
- Chairperson, BoS of the concerned subject
- A Senior Faculty member of the concerned subject
- External member/ Subject Expert from outside the University
- The Director, Admissions, MGU will be Convenor.
- 7. In case the college fulfills the specified conditions, the University may accord recognition to it as Research Centre of Mahatma Gandhi University in the concerned subject/ department for a period of Five years. However, it is mandatory that the College shall submit the annual performance report in the specified format available with the office of the Director, Admissions along with an annual fee of Rs. 5000/-. In case of failure to do so, the University reserves the right to cancel the recognition granted, after serving a notice.
- Recognition as research centre shall be accorded subject wise, based on all relevant facilities for Research, Recognized supervisors or qualified staff eligible for recognition as Research supervisors in the subjects in which the recognition is sought.
- Eligible aspirant teachers have to fulfill the eligibility conditions of Mahatma Gandhi University for recognition as Research Supervisor (will be circulated along with the application form of Research Centre recognition).
