**TERMS AND CONDITIONS OF THE TENDER FOR DISPOSAL OF OLD VEHICLES**

1. The vehicle is stationed at Mahatma Gandhi University Campus as mentioned in the Tender notification and can be inspected from 04.07.2022 between 11.00 A.M. to 3.00 P.M. The bidders are requested to contact the Registrar, Mahatma Gandhi University to visit the sites where the vehicles are stationed.
2. Bid forms along with tender documents can be obtained from the Office of the Registrar, Mahatma Gandhi University, on payment of Rs.5,000/- (Rupees five thousand only), through a Demand Draft drawn in favour of the Registrar, Mahatma Gandhi University, Nalgonda from 04.07.2022 to 12.07.2022 between 11.00 A.M. to 3.00 P.M. The Tender forms can also be downloaded from the official website of the University; in that case, the Demand Draft towards cost of application should be enclosed to the Tender bid.
3. The tenders should be accompanied with the prescribed EMD of Rs.10,000/- (Rupees ten thousand only) in the form of Demand Draft drawn in favor of the Registrar, Mahatma Gandhi University. Tender Bids without EMD will be summarily rejected.
4. The sealed tender bids should be submitted at the office of the Registrar, Mahatma Gandhi University on or before 12.07.2022 by 3.00 P.M. The Tenders will be opened on 13.07.2022 at 11.00 AM.
5. Vehicle will be allotted to the successful highest bidder against full payment of the bid price through a Demand Draft drawn in favor of the Registrar, Mahatma Gandhi University, Nalgonda, which should be arranged within three (03) working days from the date of opening of the tenders and allotment of vehicle.
6. The delivery of the sold vehicle will be given only after the successful bidder submits vehicle cost DD and documentary evidence in support of residential status (Ration Card/ Voter Identity Card in case of individual and Registration Certificates in case of firms etc). The sold vehicle shall have to be removed by the successful bidder immediately at his own expenses. The vehicle will be disposed off on “as is where is basis” and no guarantee for its worthiness or quality will be given by this University.

7. The successful bidder will also be responsible for getting the Registration certificate of the vehicle transferred in his name at his own cost expeditiously. This office is not responsible for any lapse on his part in this regard.
8. Applicable taxes as specified by the Government of Telangana are to be paid by the bidder in addition to the bid amount.
9. Failure to pay the bid amount, within the stipulated period and to remove the vehicle within the specified time will result in the forfeiture of EMD.
10. All rights to decide the final bid are reserved with the undersigned whose decision will be final.
